(This section must be signed below)**

I hereby agree:

1. To waive any and all claims that I may have against the Programme, its permit holder(s), instructors, representatives, volunteers, contacts, other registrants, or anyone connected with this organisation in any way directly or indirectly (hereinafter referred to as "Releasees");
2. To release the Releasees from any and all liability for any type of loss, damage, injury or expense sustained by the Registrant or its next of kin resulting from Registrant's participation in the Programme due to any negligence or breach of contract on the part of the Releasees in operating the Programme and;
3. To hold harmless and indemnify the Releasees from any and all liability for any property damage or injury to any third party resulting from the Registrant's participation in the Programme howsoever caused and;
4. To ensure that my child obtains permission from his/her Instructor if there is a need to leave the rink surface before the end of the class and to ensure that a parent or guardian is available to pick up my child(ren) at the end of class and;
6. To ensure that if my child is in level "A" or "B" (see level of ability on registration form) and/or is under the age of 9, he/she will wear a CSA approved hockey helmet with chin strap at all times while on the ice surface.

I, the undersigned, accept and understand that there are inherent and other risks involved in figure skating which can result in personal injury, and I freely assume those risks. I have read, understood and accept the conditions of this Release Agreement. I am 18 years of age or older OR if the person is under 18, I am the legal Parent or Guardian of the Registrant. I have the authority to grant this Release and I accept full responsibility for any problems which may occur when I and/or my child takes part in any aspect of this Programme.

REGISTRATION

- **Register early to avoid the WAITING LIST.**
- Start date will be recorded on the SFSA Hotline. The program usually starts in early December. You must do the following to properly register, and ensure your spot in the program: (a) supply the information above, (b) **Sign** the Release Agreement on the **reverse** of this form, supplying the name of the Registrant, (c) attach a cheque for \$70 (d) mail or drop off to the address above. Please note that there will be **no refunds** after the first two lessons, except in special circumstances. Please do not put more than one Participant on a form.

QUESTIONS?

- The hotline (number above) will contain a taped message of all the standard information needed for interested parties. If, however, you still have unanswered questions, you will be able to leave a message at the end of the tape. Calls are returned weekly by a volunteer.
- Messages sent by e-mail through our website (www.sfsa.ca) may be answered more frequently.

FIRST LESSON

- Note that the 1st Sunday after the ice is in place will be the 1st lesson (weather permitting).
- Remember your time slot (i.e. first preference) you indicated on this form. There will be **no** reminder phone calls for Participants after they register.
- However you will be contacted by SFSA if a time slot change is requested. Ages 4 to adult are accepted.
- Except in certain circumstances, young children must be able to remain on the ice surface without parental assistance.

CANCELLATIONS

- Although every effort is made to offer lessons each week, there are times when weather conditions, such as severe cold, storms, or mild temperatures, will cause a cancellation. If you are unsure about cancellations, please call the Hotline number, which should have the latest information by 9:30 am. If you are traveling a large distance, and can't get information on cancellations, you might decide on your own not to attend.
